This accessibility statement applies to the website of Blenheim Park Academy.

This website is run by Blenheim Park Academy. We want as many people as possible to be able to use this website.

Compliance status

This website is partially compliant with the Web Content Accessibility Guidelines (WCAG) version 2.2 AA standard, due to the non-compliances listed below.

Non-accessible content

The content listed below is non-accessible for the following reason(s): -

(a) Non-compliance with the accessibility regulations

Some images may not have a meaningful text alternative, so people using a screen reader cannot access the information. This fails WCAG 2.2 success criterion 1.1.1 (non-text content). We plan to review text alternatives during future website updates and when new content is published. When we publish new content, we'll make sure our use of images meets accessibility standards

Some older PDF and Word documents may not be fully accessible to assistive technologies. This may include missing document structure, headings or alternative text. This fails WCAG 2.2 success criterion 1.3.1 (Info and Relationships). We plan to ensure that new documents published to the website meet accessibility standards where possible and will review older documents when they are updated or replaced.

Some third-party content or embedded functionality, including social media feeds and external services, may not fully meet accessibility standards.

We are unable to fully control the accessibility of third-party systems but will review alternative accessible options where possible.

Some text and interactive elements may not meet minimum colour contrast requirements. This may make parts of the website more difficult to read for some users. This fails WCAG 2.2 success criterion 1.4.3 (Contrast Minimum). We will review colour contrast as part of future website updates and ongoing maintenance. However, the website includes a high visibility viewing option to support accessibility needs.

Some interactive or embedded components may present accessibility challenges for keyboard-only users.

We will continue to review the website as part of ongoing maintenance and future development work to improve keyboard accessibility where possible.
